



  - B. THE SERVO CYLINDER ASSEMBLY, P/N 204-076-511-9, NSN 1650-01-016-3572 HAS NOT BEEN A REPORTABLE ITEM. REPORTING OF THIS ITEM WILL REDUCE THE NUMBER OF TRANSACTIONS REQUIRED BY THE INSTALLATION OR REPLACEMENT OF THE SERVO CYLINDER ASSEMBLY.
